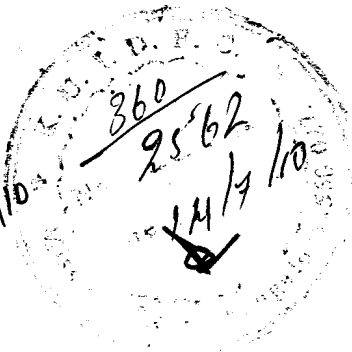

In view of the circumstances explained in the preamble, Government of Karnataka is pleased to constitute a city level committee to review and monitor the progress of the projects and reforms under JNNURM (UIG & BSUP) each for Bangalore and Mysore city with the following composition.

The Commissioners of the concerned City Corporation shall send a proposal to the Government indicating the names and details of the citizens from CVTC of their city for nomination.

The committee shall perform the following tasks:

- i. Review Physical and Financial Progress of projects
- ii. Review Progress on Reforms.
- iii. Review bottlenecks in implementation of reforms and projects and the way forward.
- iv. Convergence of projects under UIG/UISSMT and BSUP/IHSDP as well as convergence of other initiatives at the city/district level with JNNURM.

Functioning of the Committee:

- (i) The committee shall meet quarterly and conduct review of implementation of projects and reforms.
- (ii) The committee shall submit minutes of the meetings/discussion held and recommendations to the concerned ULBs and SLNAs and State Governments concerned.

- (iii) The SLNA shall ensure that minutes are uploaded on the web and copy is sent to MoUD and MoHUPA. The SLNA shall also ensure that action is taken on the recommendations of the committee and action taken report is submitted to the State Government and MoUD & MoHUPA. The action taken report must be on the agenda item of all the meetings of the Committee.
