1. Title and commencement.- (1) these rules may be called the Karnataka Right to Information (Disclosure of Information by Authorities Providing Municipal Services) Rules,2009.

(2) It shall come into force at once.

2. Definitions- (1) in these rules, unless context other-wise requires,-

(a) 'Act' means the Right to Information Act, 2005 (Central Act 22 of 2005).

(b) 'Disclosure of information' means disclosure of information as enumerated in the schedule.

(c) 'Authorities' means,-

(i) A Municipal Corporation constituted under the Karnataka Municipal Corporation Act, 1976 (Karnataka Act 14 of 1977) or a City Municipality or a Town Municipality and a Town Panchayat constituted under the Karnataka Municipalities Act 1964 (Karnataka Act 22 of 1964) And such other institutions or committees of self government constituted under article 243Q of the constitution of India, such other authorities providing municipal services.


